

This warranty applies to the function of Plannja rainwater systems. This warranty is supplementary to Plannja AB's commitments under the terms of delivery applicable on the date of delivery. This warranty is valid from the date of purchase for deliveries made from and including January 2005.

The warranty coverage period is 15 years. The consumer's legal rights are not affected by this warranty. According to the stated terms, Plannja warrants that our factory-coated rainwater systems will not be subject to rust-through (corrosion perforation) within the warranty coverage period as a consequence of manufacturing or material defects.

Terms of the warranty

This warranty is valid for rainwater systems for buildings.

The warranty does not cover products that are used in particularly corrosive or aggressive environments, e.g., in atmospheres with high salt content such as in coastal areas (near saltwater), nor does it cover products exposed to corrosive chemicals, corrosive smoke, condensation and ash, cement dust or manure.

Furthermore, the warranty is valid under the following conditions:

- a) The product has been installed according to installation instructions applicable at the time of sale.
- b) The product has not been damaged physically, mechanically, chemically or due to other external influence.
- c) Damage due to sheet metal work causing breakage of the surface coating is remedied with touch-up paint by the installer of building owner.
- d) Metal shavings resulting from cutting, drilling or similar operations are removed immediately.
- e) Eaves troughs and down pipes are inspected and leaves and other debris that can hinder the free discharge of water are removed annually.
- f) The product is not stored or used in contact with or close to damp, corrosive material.
- g) The product is not exposed to contact with copper or fluid flowing from copper pipe.
- h) Fasteners and sealers appropriate for the relevant corrosivity class are used.
- i) The material has been installed not later than 6 months after date of invoice.
- j) Claims are made in writing to Plannja within three months of discovery of the damage or such time as the damage ought reasonably to have been discovered.
- k) Plannja or Plannja's representatives are given opportunity to inspect products for which claims are submitted under the terms of this warranty.

Remedies

With respect to any failure of a product covered by this warranty to comply with this warranty Plannja shall deliver to the buyer, within a maximum of 60 days, new products from the current product range as replacements for defective products. Liability for costs under the terms of this warranty shall not exceed the original invoiced amount of the product(s) for which a claim is submitted. After 10 years, Plannja's liability is reduced to half of the original invoiced amount.

Plannja shall not be liable in any event for any consequential, indirect, incidental, or special damages arising from such damages as are described herein. The corresponding warranty on surface coating for the replacement products or re-painted products shall apply for the remainder of the original warranty coverage period.

Plannja shall not be liable in any event for any loss of income.

Warranty claims will be handled provided that the sheet material can be identified and that a copy of the invoice, receipt or other purchase document is presented.
