

Warranty; Plannja Sheet

ABM07 conditions (Swedish; General Construction Purchase Conditions) apply to Plannja deliveries. Warranty conditions refer to applicable parts of ABM07. The warranty is valid from the date of purchase for deliveries from January 1, 2013. The consumer's legal rights are not affected by this warranty.

The warranty covers colourfastness and flaking on Plannja construction sheet painted in standard colours, and as a warranty against rust-through; refer to Table 1.

In accordance with the conditions stated herein Plannja hereby guarantees that, during the warranty period, the colour coating will not flake or otherwise fragment, display abnormal colour changes or rust through causing leaks as a result of manufacturing or material defects.

The warranty period is counted from the date of delivery to the construction site or 18 months from the date of manufacture, whichever is the sooner. Abnormal colour change refers to 8 CIELAB units over 5 years, 16 units over 10 years or 20 units over 15 years respectively. Measurements to be carried out on cleaned surfaces.

Warranty conditions

The warranty applies to Plannja sheet used for roofing or wall cladding on buildings on condition that installation, annual inspection and maintenance have been carried out in a professional manner and in accordance with Plannja's directions and instructions. The brochure Advice on the choice of materials and maintenance of Plannja products, which is available at www.plannja.se, is supplementary to this warranty and its contents should be considered when selecting Plannja products, accessories, installation and maintenance.

The warranty is valid for the use of standard paints in normal environments as described in C1–C4; refer to Table 2. The warranty does not cover use in especially corrosive or aggressive environments e.g. in air with a high salt content such as saltwater coastal areas, or sheet in contact with water or where corrosive chemicals, corrosive fumes, condensation and ash, cement dust or animal droppings may affect the surface. The warranty does not cover the protective coating on the back of the sheet or surfaces with touch-up paint.

Contact with wet cement, wet timber, soil or other surfaces has been avoided and the sheet has not been used in contact with damp, corrosive materials that may cause galvanic corrosion.

The warranty does not cover damage that can be shown to arise from incorrect storage e.g. in damp, corrosive environments or at abnormal temperatures.

The product must be installed within six months from the date of invoice.

For damage to be covered by a warranty claim it must exceed 5% of the product's total installed surface area.

The product must be used in environments with weather conditions considered normal for the specified corrosion classes.

Claims must be made in writing to Plannja within three months of the date when the damage was discovered or should have been discovered. The dealer/supplier must be informed of warranty claims.

Plannja or Plannja's representative must be given an opportunity to inspect any product subject to claims under this warranty.

The warranty is also valid on condition that

- the product was installed in accordance with installation instructions and brochures valid at the time of purchase,
- metalwork takes place at temperatures specified in Plannja's Technical Data Sheets,
- bending radii comply with Plannja's Technical Data Sheet and that sheet metal is not subjected to heavy rebending,

d) max temperature for use of Plannja coating systems is 80°C,

e) suitable fasteners and sealants are used for the applicable corrosivity class,

f) the product and its coating are not damaged mechanically or chemically,

g) damage from metalworking that has caused penetration of the surface coating is remedied with touch-up paint by the installer or building owner,

h) metal swarf from cutting, drilling and suchlike is removed immediately,

i) water is able to run freely from all sheet metal surfaces,

j) accumulations of dirt or other deposits and areas sheltered from rain have been washed in a workmanlike manner.

Compensation rules

If a legitimate claim is made according to the conditions of this warranty, Plannja undertakes, at its discretion, either to meet the costs, in whole or in part depending on the age of the sheet, for repainting the defective sheet or for delivering new sheet free of charge to the purchaser as a replacement. Measures taken must be the most practical and at reasonable cost. Liability for costs is limited to the original invoiced amount for the sheet delivery concerned. Plannja will not provide compensation for loss of business. Plannja is not liable under any circumstances for direct or indirect losses arising from damage as described in this warranty. An equivalent surface coating warranty for replaced or repainted sheet will apply for the remainder of the original warranty period.

The size of the compensation will take into consideration the number of years the building has fulfilled its function and its remaining service life. The following guidelines apply to surface coating flaking and abnormal discolorations (Table 3). Repainting costs refer to total costs; new sheet costs refer to sheet only.

Damaged sheets are replaced in cases where rust-through has caused leaks.

Warranty claims will be processed provided that the sheet material can be identified by order number and that a copy of the invoice or other purchase document is presented.
